AUCTION NOTICE

Imphal, the 20th August, 2020

No. 6/8/2016-17/DFO/C (Auction) :- It is hereby notified for information of HPC Cleared Wood Based Units situated within the Minor Industrial Estates and the general public that e-auction sale of seized Pine logs (i) Lot-A-11 logs (2.713 Cum), (ii) Lot-B-8 logs (3.10 Cum) and (iii) Lot-c-8 logs (2.506 cum) dumped at Mantripukhri Forest Complex of Pine logs of A-II Class shall be held on 27/8/2020 under the following terms and conditions:-

1. Any individuals/registered qualified Forest Contractors/ HPC cleared saw mills may join the e-auction sale.
2. The e-auction sale will be held on 27/08/2020 through the Online Portal of Forest Department, Manipur from 10 am and onwards.
3. The Pine logs will be sold in whole lots as mentioned above.
4. Intending bidders may inspect the timber/logs lying at Mantripukhri Forest Complex and satisfy themselves of the quality and quantity of the timber before joining the e-auction. No complain about the quality and quantity of the timber after the e-auction sale bid will be entertained.
5. Intending bidders should deposit a sum of Rs. 5,000/- in the form of D-at Call for the whole lot drawn in favour of Divisional Forest Officer, Central Forest Division, Manipur from SBI or any other Schedule Bank as earnest money deposit for joining the e-auction sale.
6. Sawing of the purchased timber is allowed only at authorised saw mills cleared by the HPC.
7. The earnest money deposited shall be refunded after finalization of the e-auction sale. For successful bidder, the amount will be adjusted towards the amount to be paid by them.
8. Amount once bided cannot be withdrawn. In case of withdrawal, the earnest money deposited will be forfeited.
9. Successful bidder should deposit the bid amount along with GST @ 12% of the bid amount to the Division Office within 3 (three) days of the approval, failing which, the earnest money deposited will be forfeited to the Government and the e-auction will be disposed off in favour of the next 2nd higher bidder.
10. The Divisional Forest officer, Central Forest Division reserves the right not to accept or reject any tender/bid without assigning any reason thereof.
11. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
12. Should any dispute arisen, decision of the Conservator of Forests, Central Circle shall be final and binding to the parties.
