
**AUCTION ORDER**

Chandel, the 8<sup>th</sup> February 2021

In continuation of Order of even no. dated 20<sup>th</sup> January 2021, and as there were no bidders for the said auction and in accordance to the powers conferred u/s 56 of Indian Forest Act, 1927, in connection with Offence Report No. POR/CHD/2021/3724, the following seized/confiscated forest produces, which are government properties, shall be sold by way of public auction through second online bidding process till midnight of 18<sup>th</sup> February 2021 :

1. Only HPC approved sawmills, located in proper MIEs are eligible to bid in the Auction.
2. The Forest produces will be sold in as-is-where-is basis. Interested individuals/parties can check the quality and quantity during office hours. No complaints will be entertained once Bid is awarded after the cut-off date. Details of trees including species and size can be seen from the notice board.
3. Interested bidders had to deposit 5% of the Floor price as D-at Call for e-auction sale (in form of DD/ Cheque, payable to Divisional Forest Officer, Chandel Forest Division), Which will be adjusted in case of winning bid and refunded, if lost.
4. The timber, thus awarded should not be sawn at any other Sawmill other than licensed and HPC approved Sawmills.
5. Only online bidding is allowed via <https://forest.manipur.gov.in/tenders> and no other means of bidding will be allowed. No more advertisement will be made on this auction in Newspapers.
6. Successful bidder should deposit the bid amount along with 18% GST to the Division Office within 3 days of the final approval, failing which the earnest money deposited will be forfeited to the Government and e-auction will be disposed off in favour of the second highest bidder.
7. Loading and transportation cost should be borne by the bid winners. The undersigned will issue Transit pass for the forest produces once auctioned amount is settled.




8. The timber shall be for consumption within the State of Manipur only and no permit for transportation of the timber in log from outside the state shall be granted. The bidder shall apply for Transit Pass for the auctioned quantity before movement.
9. The Divisional Forest Officer, Chandel Forest Division, Chandel reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
10. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
11. In case of any dispute, the decision of the Principal Chief Conservator of Forests & HoFF, Government of Manipur shall be final and binding to all the parties.


