
1. HPC cleared saw mills located within approved MIE/wood base Units/Reg Forest contractors/any individuals may join the E- Auction sale
2. The forest produce will be sold in as is where is basic. Interested bidders may check the quality & quantity of the timbers during officer hours details of the timbers can be seen from the office board no complaints will be entertained once bid is awarded after the cut of date
3. Auction sale will be done in 4 lots, i) **Lot-I** 53 sawn timber of Teak special containing 4.762 cum ii) **Lot-II** 42 sawn timber of Teak special containing 4.785cum iii) **Lot-III** 44 sawn timber of Teak containing 4.647cum iv) **Lot-IV** 42 sawn timber of Teak containing 4.742 cum.
4. The intending bidders had to deposit 5% of the floor price in the form of D-at-call/Bankers cheque drawn from any scheduled bank in favour divisional Forest Officer Chandel Forest Division which will be refunded for the lost bidder & adjusted for the winners.
5. Bidding is allowed only via [https:// forest.manipurforest.gov.in](https://forest.manipurforest.gov.in) and can bid till **midnight of 25th March, 2021**. No more advertisement in newspapers & electronic media will be made
6. Successful bidders should deposit the bid amount along with 18% GST to the Division Office, Chandel Forest Division within 3 (three) days of the final approval failing which the earnest money will be forfeited.
7. Loading & Transportation cost shall be borne by the successful bidders. The undersigned shall issue Transit pass for the forest produces once auction is settled.
8. The timber shall be for consumption within the state of Manipur only and no permit for transportation outside the state shall be granted. The bidder shall apply for transit pass for the auction quantity before movement.
9. The divisional Forest Officer Chandel Forest Division reserves the right no to accept or reject any tender/bid without assigning any reason thereof.
10. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the forest Department, Manipur.
11. In case of any dispute, the decision of the Principal Chief Conservator of Forests & HoFF, Government of Manipur shall be final & binding to all parties.
