
ORDERS BY THE GOVERNOR: MANIPUR

Imphal the 2nd September, 2021

No.20/44/2021-For & Evt: Since the User Agency (PWD) has deposited the mandatory payments of CA and NPV to Manipur CAMPA, the Governor of Manipur hereby grants Working Permission for the diversion of 0.37 ha of forest land for removal of blind corner and straightening of approach road at Mongjam, Imphal East, under Northern Forest Division, Kangpokpi in the State of Manipur in favour of PWD, subject to fulfillment of the following conditions:

1. The Working Permission granted shall be valid for 1 (one) year with effect from the date of issue of this Working Permission.
2. State Forest Department shall upload the copy of "In-Principle Approval" Order of the State Government for the project proposal and the Working Permission issued by the State Government to the Website of the Forest Department to ensure availability in the public domain.
3. PWD and State Forest Department shall submit the Compliance Report of all conditions stipulated in the Order of even No., dated 2nd August, 2021 within 1 (one) year of obtaining final approval of the project from the State Government.



No.20/44/2021-For & Evt: Under the guidelines of Forest (Conservation) Act, 1980 and Forest Conservation Rules, 2003 of Section 2 (ii) of Chapter -4 and Subsection 4.3 (K) published by the MoEF& CC, Government of India and proposal from Chief Conservator of Forest/FCA, Manipur vide their letter No.7/291/2021/Forests: 336, dated 02/08/2021 , the Governor of Manipur is pleased to accord General Approval (Stage -1 Clearance) for the diversion of 0.37 ha of forest land for removal of blind corner and strengthening of approach road at Mongjam, Imphal East, Manipur under Northern Forest Division Kangpokpi, Manipur subject to the following conditions:-


- i. The legal status of the forest land shall remain unchanged.
- ii. The User Agency shall physically demarcate the diverted forest area by constructing RCC boundary pillars, Protection walls/Retaining walls shall be constructed at the project costs at vulnerable points to prevent landslides and soil erosion.
- iii. The User Agency shall take adequate fire protection measures during the dry seasons.
- iv. Unauthorised establishment of labour camps/huts etc shall not be allowed inside and adjoining forest areas.
- v. The project involves felling of trees as reported by the Divisional Forest Officer, Kangpokpi Forest Division and USER Agency shall pay the costs of extraction of the trees to be affected (As indicated at FORM-A: Part-III).
- vi. The concerned Divisional Forest Officer has assessed the bare minimum requirement of the forest land for the project.
- vii. The Nodal Officer, FCA shall submit monthly report to the Regional Office of MoEF & CC, Shillong regarding approval of the project.
- viii. User Agency shall be responsible for any loss of the flora and fauna in the surrounding area and therefore, shall take all possible measures to conserve the same.
- ix. User Agency shall pay the Net Present Value (NPV)/additional Net present value for the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.
- x. The permission granted by the state Government shall be subject to the monitoring by the concerned Regional Office of the Ministry of Environment, Forest & Climate Change, Government of India.
- xi. The Forest land shall not be used for any purpose other than that specified in the proposal. Any change in the land use without prior permission of the Central/State Government shall amount to the violation of Forest (Conservation) Act, 1980. Request for such change shall be made to the Regional Office by the Nodal Officer, FCA, Manipur.



- xii. Certificate for settlement of rights has been obtained under FRA 2006.
- xiii. The project does not affect recognised rights of the primitive tribal communities and pre-agricultural communities.
- xiv. The State Forest Department shall upload the forest diversion order/letter issued by the State Government to the website of the Forest Department (www.manipurforest.gov.in)
- xv. The USER Agency may be allowed to transport the excess earth, if any, with prior permit of the DFO, Kangpokpi and on payment of Royalty etc according to Rule No.33 of the Manipur Forest Rules, 1971 and Hon'ble Manipur High Court Order dated 25/07/20218 passed in M.C. (PIL) No.29 of 2017 with PIL No. 25 of 2017.
- xvi. The user agency should publish the entire forest clearance granted in verbatim along with the conditions and safeguards imposed by the state government in two widely circulated local daily newspaper one in vernacular language and the other in English language so as to make people aware of the permission granted to the project proponent for use of forest land for non-forest purposes.

2. After receipt of the Compliance Report from the USER Agency on fulfilment of the conditions mentioned above, Final Approval will be issued in this regard. Formal transfer of forest land will not be effected till Final Approval orders are issued by the State Government.
