**Terms and conditions of the e-auction sale of the converted logs vide auction
notice No.3/18/2016-17/DFO-WL: dt. 06/12/2022.**

1. Any registered Wood Based Unit/HPC cleared Saw Mills located within approved MIEs/Wood Based units/Individuals may join the e-auction sale.
2. The intending bidders may register at the Forest Department portal forest.manipurforest.gov.in for participating in the e-auction sale bid till **4 p.m. of 20/12/2022.**
3. The intending bidders may inspect the logs and get themselves satisfied of the quality and quantity of the converted logs before joining the auction sale. No complaint on the quality and quantity of the logs after finalization of the auction sale shall be entertained. Details of logs including species and size can be seen from the notice board.
4. The intending bidders shall deposit Earnest Money @ 5% of the value of the floor price of the converted trees along the section of roads they are interested to bid in the form of D-at-Call/Banker's Cheque from any scheduled bank drawn in favour of Divisional Forest Officer Wildlife for joining the e-auction sale.
5. The earnest money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
6. Amount once bided cannot be withdrawn. In case of withdrawal, the earnest money deposited will be forfeited to the Government.
7. The logs shall be for consumption within the state of Manipur only and no permit for transportation of logs outside shall be granted.
8. The successful bidder shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of the approval of rate by the competent authority failing which, the EM will be forfeited to the Government.
9. The Divisional Forest Officer/Wildlife Division reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
10. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
11. In case of any dispute, the decision of the **Chief Conservator of Forests/Wildlife, Government of Manipur** shall be final and binding to all the parties.

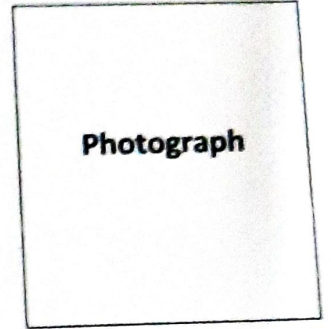
