e-AUCTION NOTICE

Tamenglong, the 16th January, 2023

No. 3/30/TFD/2018-19: In accordance with the power conferred u/s 56 of the IFA, 1927, the seized/confiscated forest produce, in connection with Forest offence Reports- POR/TMG/2023/9714 dated 06/01/2023 and subsequent confiscation order No.3/30/TFD/2018-19 dated 13/01/2023 O/o Divisional Forest Officer, Tamenglong Forest Division measuring 47.25 cft. Of B- Class timber and POR/TMG/2023/9724 dated 12/08/2021 of the Range Forest Office, Tamei and subsequent confiscation order No.3/30/TFD/2018-19 dated 16/01/2023 of the O/o Divisional Forest Officer, Tamenglong Forest Division, measuring 57.5 cft. of C- class (scantlings) and 188.19 cft of B-class (round logs), will be disposed of by way of e-auction. The auction will be done in 3 lots from 16/01/2023 to 20/01/2023 and shall be open on 20/01/2023 at 01:00 pm (abstract of lots, floor price/upset price, earnest money, etc. are enclosed in **Annexure I**).

TERMS AND CONDITIONS

1. Any registered Forest Contractors/HPC cleared Sawmills located within approved MIEs/Wood based Units/Individuals may participate in the e-Auction sale.
2. The intending bidders may register at the Forest Department portal www.forest.manipurforest.gov.in for participating in the auction sale and bid till 11:00 AM of 20/01/2023.
3. The intending bidders may inspect the logs and get themselves satisfied of the quality and quantity of the logs and sawn timbers before joining the auction. No complaint on the quantity and quality of the logs after finalization of the auction sale shall be entertained. Details of lot(s) can be seen from the notice board.
4. The intending bidders shall deposit Earnest Money @ 5% of the value of the floor price of the timber as shown in Annexure-I, in the form of D-at-Call/Banker's cheque for the log(s) he/she intends to apply to be drawn in the favour of the Divisional Forest Officer, Tamenglong from any Scheduled Banks or in Cash to the O/o the DFO, Tamenglong for joining the e-Auction sale.
5. The rates should be offered for an entire lot and no part of a lot can be bidden separately. A bidder can bid for all the lots, but separate bids should be offered for each lot.
6. The Earnest Money deposited shall be refunded after the finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
7. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money deposited will be forfeited to the government.
8. The successful bidders shall deposit the bid amount along with taxes to the Division Office within 5 (five) days of approval of rate by the competent authority, failing which, the EM will be forfeited to the government.
9. The Divisional Forest Officer, Tamenglong Forest Division reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
10. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur
11. In case of any disputes, the decision of the Conservator of Forests, Western Circle, Government of Manipur shall be final and binding to all the parties.
