1. Any registered Forest Contractor/ HPC approved Saw Mill under approved MIEs/Wood Based Units/ Individuals may join the Auction sale.
2. For eAuction - The intending bidders may register at the Forest dept. portal [forest.manipurforest.gov.in](http://forest.manipurforest.gov.in) and also get themselves register through APF (to be provided by Division) for participating in the eAuction sale and bid till the end of scheduled time fixed by the concerned authority of the auction sale
3. For Manual Auction - The intending bidders may register through the Auction Participation Form (APF) provided by the Division office by paying the applicable registration fee.
4. Auction sale of Khangra logs will be done in lotwise.
5. The intending bidders may inspect the Khangra logs and get themselves satisfied of the quantity and quality of timber before joining the auction. No complaint shall be entertained after finalization of the auction sale. Details of the Timber to be auction are notified on the Notice board.
6. The intending bidders shall submit the duly filled in Auction Participation Form under Annexure A along with the Earnest Money@5% of the value of timber at floor price which is **Rs. 266/cft** for round logs in at remote and border areas of the state of Manipur, as fixed vide letter dt. 22/09/2022 O/o Secretariat, Forest, & CC Department, Manipur.
7. The Earnest Money (EM) deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and condition of the auction sale are violated.
8. Amount once bid cannot be withdrawn in case of withdrawal, the EM deposited will be forfeited to the government.
9. The successful bidders shall deposit the bid amount along with applicable taxes to the Division Office within 5 (five) days of the approval of rate by the competent authority, failing which the EM will be forfeited to the Government.
10. The highest bidder should complete the transportation of the timber within the current financial year 2022-23 i.e. by 31<sup>st</sup> March 2023. The request for further extension will be issue by the DFO, Kamjong by payment of 25% of the bid amount, if the timber transit are not completed within the set timeline.
11. The timber shall be for consumption within the state of Manipur only and no permit for Inter-state transportation shall be permitted or issue.
12. The Divisional Forest Officer, Kamjong Forest Division reserves the rights not to accept or reject any tender/ bid without assigning any reason thereof.
13. Acceptance of the bid amount will be subject to approval of the appropriate authority of the Forest Department, Manipur.
14. In case of any dispute, the decision of the Conservator of Forests, eastern circle, Govt. of Manipur or appropriate authority of the Forest Department, Manipur shall be final and binding to all the parties.
