**TERMS AND CONDITIONS OF E-AUCTION NOTICE NO. 5/10/2019/DFO-SPT**

Senapati, the 09<sup>th</sup> October, 2023

1. Any registered Forest Contractors/HPC cleared Saw Mill located within approved MIEs/Wood based Units/Individuals may join the E-Auction sale.
2. The intending bidders may register at the Forest Department portal forest.manipurforest.gov.in for participating in the auction sale and bid till 05.00 pm of 12<sup>th</sup> October, 2023.
3. Auction sale of the sawn teak timber will be done in 12 lots, i.e., i) **Lot 1:** 76 cft ii) **Lot 2:** 78 cft iii) **Lot 3:** 82 cft. iv) **Lot 4:** 84 cft v) **Lot 5:** 80 cft vi) **Lot 6:** 84 cft vii) **Lot 7:** 80 cft viii) **Lot 8:** 78 cft ix) **Lot 9:** 72 cft x) **Lot 10:** 72 cft xi) **Lot 11:** 80 & **Lot 12:** 84 cft.
4. The intending bidders may inspect the sawn timber and get themselves satisfied of the quality and quantity of timber before joining the auction. No complaint on the quality and quantity of the timber after finalization of the auction sale shall be entertained. Details of sawn timber can be seen from the notice board.
5. The intending bidders shall submit the duly filled in auction participation form (Annexed) along with the Earnest Money @ 5% of the value of the floor price in the form of D-at-Call/Banker's cheque from any Scheduled Bank drawn in favour of Divisional Forest Officer, Senapati Forest Division, Manipur or in Cash to the O/o. DFO/Senapati for joining the E-auction sale for each lot latest by 05:00 pm of 12/10/2023 which will be refunded for the lost bidder and adjusted for the winners.
6. The Earnest Money deposited shall be refunded after finalization of the auction sale or may be forfeited to the Government if the terms and conditions of the auction sale are violated.
7. Amount once bided cannot be withdrawn. In case of withdrawal, the Earnest Money deposited will be forfeited to the government.
8. The successful bidders shall deposit the bid amount along with 18% GST to the Division Office within 2 (Two) days of the final approval, failing which, the Earnest Money will be forfeited to the government.
9. Loading and Transportation cost shall be borne by the successful bidders. The undersigned shall issue Transit pass for the forest produce once auction if settled.
10. The timber shall be for consumption within the state of Manipur only and no permit for transportation of timber outside the state shall be permitted. The bidder shall apply for transit pass for the auction quantity before movement.
11. The Divisional Forest Officer/Senapati Forest Division, Senapati reserves the rights not to accept or reject any tender/bid without assigning any reason thereof.
12. Acceptance of the bid amount will be subject to the approval of the appropriate authority of the Forest Department, Manipur.
13. In case of any dispute, the decision of the Principal Chief Conservator of Forests & HoFF, Government of Manipur shall be final and binding to all the parties.
