No.2/44/2023/Forests: ⁸⁰² In pursuance of letter No.8/306/2013-For. & Envt dated 23.02.2024 of Secretariat: Forest, Environment & Climate Change Department, Manipur, to re-conduct the Recruitment examination for the post of Forest Guard only, Applications are invited from the Indian citizens in the prescribed form for Appointment to the post of FOREST GUARD on **temporary basis** through sponsorship of the concerned Employment Exchanges. The details of the post are as follows:

1. **Name of the Post** : FOREST GUARD
2. **Pay** : Rs.5200-20200 Pre-revised (Rs.18000/- ROP 2019) with admissible allowances
3. **Class/Group** : C
4. **Number of Posts** : 70 (the vacancy may increase or decrease)
5. **Reservation** : Reservation for SC/ST/OBC Meitei/ & OBC Meitei Pangal as per the 200 PBR.

6. Candidates applying for reserve posts must submit the Caste/Tribe/OBC Certificates issued by the Competent Authority along with the Application Forms.
7. Candidates applying for the Sports quota must submit Certificate of representation in games/sports list at **ANNEXURE-A/1** as per the relevant Forms prescribed by the Department of Personnel, Government of Manipur vide Office Memorandum No.9/1/83-DP dated 17.10.1998 and issued by the Competent Authority.

8. Conditions of Eligibility:

- (i) **Nationality:** The Candidate must be a citizen of India & a resident of Manipur.
- (ii) **Age Limit:**
 - (a) 18 years to 38 years as on 31st March 2024. Upper age limit shall be relaxed upto 5 years for the candidates belonging to Schedule Caste or Schedule Tribe and upto 3 years for the candidates belonging to OBC.
 - (b) **However, Candidates who have appeared in the Forest Guard Recruitment Examination held on 16.02.2020, are allowed to appear regardless of conditions mentioned in (a) above if, they so desire.**
- (iii) **Educational Qualification:**
 - (a) Essential: Matriculate/ Class-X passed.
 - (b) Desirable: Knowledge of English, Hindi and Manipuri.
- (iv) **Physical Standards:** Candidates must have the following physical standards in minimum:

Minimum Height of 152 cm for male candidates and 145 cm for female candidate is allowed in case of candidates belonging to Schedule Tribe and races such as Assamese, Bhutanese, Garhwalis, Gorkhas, Mizos, Nagas, Nepalese, Sikimese and Manipuri and those from Arunachal Pradesh, Lahaul and Spiti and Meghalaya.

9. **Application Fee:** Candidates belonging to UR/OBC category are required to pay a non-refundable Application fee of Rs.500/- and Rs.250 for candidates belonging to SC/ST category and the payment receipt should be submitted at the time of submission of Application Form. *For online payment of fees, necessary payment gateway shall be made available from 15th March 2024. One may visit our website www.forest.manipurforest.gov.in or visit any of the Offices mentioned in para No. 16 of this notification to obtain the information on payment gateway. Those desiring to pay in offline mode will need to pay in cash at the time of the submission of the Application Form.*

However, candidates who have appeared in the Forest Guard Recruitment Examination held on 16.02.2020, are exempted from payment of the application fee.

10. **Rejection of Application Form:** Incomplete Application Form and wrongful submission of Application Form are liable to be rejected.
11. **Written Test:** Candidates are required to appear in a written test examination consisting of multiple-choice objective type questions in the subject given below:

12. **Medical Examination:** The shortlisted Candidates will be required to appear for medical examination at a designated hospital at their own cost for appearing before the designated Medical Board.
13. **Physical Test:** The shortlisted Candidates are required to appear for physical Test. Male Candidates must pass a walking test covering a distance of 25 km and the Female candidates 16 km within 4 hours duration on foot.
14. **Appointment:** The Candidates selected in order of the merit list shall be appointed as Forest Guard on Temporary Basis and the probation period shall be 2 years. They are required to join Forest Training School to undergo 1(one) year Training Course as prescribed in Manipur Forest Rules, 2009.

15. Application Form:

- (i) **For Candidates who appeared in the FG Recruitment Examination held on 16.02. 2020:** Separate Application Form, **FORM No.I (Non-Sports quota) & FORM No. I(A) (Sports Quota)** will be available in the Office of the Principal Chief Conservator of Forests & HoFF, Sanjenthong, Imphal or the office of the Territorial Divisional Forest Officer's Offices Jiribam/ Tamenglong/Noney/ Kangpokpi/ Senapati/ Kamjong/ Ukhrul/ Chandel/ Tengnoupal/ Churachandpur/



/Central/ Bishnupur & Thoubal from **13th March 2024 from 11 am to 4.30 PM** on all working days.

- (ii) **Fresh Candidates:** Application Form shall be issued to those candidates sponsored by the respective District Employment Exchange Office. The Application Form (**FORM No.II**) will be available from the office of the Principal Chief Conservator of Forests, Sanjenthong, Imphal from 11 am to 4.30 pm on all working days from 13th March 2024. Additionally, Application Forms will also be available in all the territorial Divisional Forest Officer's office located in all the districts of Manipur. Separate application form (**FORM-II/A**) as prescribe by the O.M. dated 17.10.1998 shall be issued to the candidates applying for appointment of Meritorious Sports Persons in relaxation of the Employment Exchange Procedure.

- (iii) **No application received after the last date shall be entertained.**
